The undersigned, for the purpose of forming a corporation under the Florida General DA Corporation Act, do hereby adopt the following Articles of Incorporation:

Article I. Name.

The name of the Corporation is: ONE CELLULAR STOP, INC.

Article II. Duration.

The duration of the Corporation is perpetual.

Article III.
Purpose.

The general purposes for which the Corporation is organized are the following:
