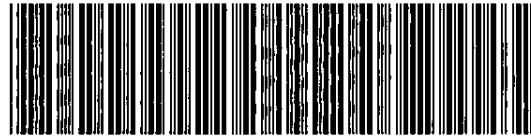

Pursuant to § 607.1401, Florida Statutes, this Florida for-profit corporation submits these Articles of Dissolution:

1. The name of this corporation is Rocket Man Florida Investments Corporation (the "Corporation").
2. The Corporation's outstanding and issued share capital consists solely of shares of common stock ("Common Stock").
3. The sole shareholder of the Corporation's Common Stock has elected, pursuant to written consent, effective as of July 18, 2011, to dissolve and liquidate the Corporation.
