1. The Plan of Merger (the "Plan of Merger") attached hereto as Exhibit A, and made a part hereof, was unanimously approved in compliance with the laws of the state under which it is organized and adopted by each of the sole shareholders and each of the sole directors of both Disappearing Corporation and Surviving Corporation.

Pursuant to Article 5.04 of the Texas Business Corporation Act and Section 607.1105 of the Florida Business Corporation Act (the "Act"), R E C, INC., a Texas corporation, Entity Number. 800050588 ("Disappearing Corporation") and PAINCARE ACQUISITION COMPANY XXII, INC., a Florida corporation ("Surviving Corporation") hereby adopt the following Articles of Merger:

1. The Plan of Merger (the "Plan of Merger") attached hereto as Exhibit A and made a part hereof, was unanimously approved in compliance with the laws of the state under which it is organized and adopted by each of the sole shareholders and each of the sole directors of both Disappearing Corporation and Surviving Corporation.

EXHIBIT "A"**PLAN OF MERGER**

In accordance with Article 5.04 of the Texas Business Corporation Act and Section 607.1105 of the Florida Business Corporation Act (the "Act"), R E C, INC., a Texas corporation, Entity Number. 800050588 ("Disappearing Corporation") and PAINCARE ACQUISITION COMPANY XXII, INC., a Florida corporation ("Surviving Corporation") hereby adopt the following Plan of Merger ("Plan"):

1. **Merger.** In accordance with the provisions of the Act, Disappearing Corporation shall be merged with and into Surviving Corporation and the separate existence of Disappearing Corporation shall thereupon cease, and Surviving Corporation, shall continue to exist under and be governed by the Act (the "Merger").

2. **Articles of Incorporation.** The Articles of Incorporation of Surviving Corporation, in effect immediately prior to the Effective Time, shall, without any changes be the Articles of Incorporation of Surviving Corporation, until further amended as permitted by law.

3. **Bylaws.** The Bylaws of Surviving Corporation, in effect immediately prior to the Effective Time, shall, without any changes, be the Bylaws of Surviving Corporation, until further amended as permitted by law.

4. **Directors and Officers.** The directors and officers of Surviving Corporation, in office immediately prior to the Effective Time, shall continue to be the directors and officers of Surviving Corporation after the Merger and shall hold office in accordance with the Articles of Incorporation and the Bylaws of Surviving Corporation.

5. **Distribution to Shareholders of the Constituent Corporations.** Upon the Effective Time, each of the issued and outstanding shares of Disappearing Corporation will be converted into and exchanged for a pro rata interest in the Merger Consideration as provided for and determined in that certain Merger Agreement and Plan of Reorganization (the "Merger Agreement") by and among PainCare Holdings, Inc., a Florida corporation, Surviving Corporation, Disappearing Corporation and Robert Carpenter, D.C., dated as of January 6, 2006. Each certificate representing issued and outstanding shares of the Disappearing Corporation shall be surrendered to the Surviving Corporation and exchanged for such interest in the Merger Consideration. Each share of capital stock of Surviving Corporation that is issued and outstanding immediately prior to the Effective Time shall continue to represent one (1) validly issued, fully paid and nonassessable share of capital stock of Surviving Corporation. Each certificate of Surviving Corporation evidencing ownership of any such shares shall, following the Merger, continue to evidence ownership of the same number of shares of stock of Surviving Corporation.

6. **Effect of Merger.** As of the Effective Time, the separate existence of Disappearing Corporation shall cease, and Surviving Corporation shall be fully vested with all rights, privileges, immunities, disabilities, and duties, of Disappearing Corporation, as more particularly set forth in the Act.
