**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, SUSAN B. SNIDER, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is EBB OF NW FLORIDA, INC.

ARTICLE II - PRINCIPAL OFFICE

The street and mailing address of the corporation's principal office is 392 Tradewinds Drive, Santa Rosa Beach, FL 32459.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.
