ARTICLES OF INCORPORATION OF

FLORIDA LANDSCAPE CONCEPTS, INC.

The undersigned subscriber to these Articles of Incorporation, does hereby form a corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes.

ARTICLE I

NAME OF CORPORATION

The name of this Corporation shall be **FLORIDA LANDSCAPE** CONCEPTS, INC.

ARTICLE II

GENERAL NATURE

The general nature of the activities of this Corporation shall be the transaction of any or all lawful business for which corporations may be incorporated under this Chapter 607 Florida Statutes.

ARTICLE III CAPITAL STOCK

- A. The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred thousand shares (100,000) of Common Stock having a par value of one dollar (1.00) per share, which shall be without preemptive rights.
- B. All or any portion of the capital stock may be issued in payment for real or personal property, services, or any other right or thing having a value in the judgment of the Board of Directors at least equivalent to the full value of the stock so to be issued as hereinabove set forth, and when so issued shall become and be fully paid and nonassessable, the same as though paid for in cash; and the Directors shall be the sole judges

- of the value of any property, right or thing acquired in exchange for capital stock, and their judgment of such value shall be conclusive.
- C. Notwithstanding the foregoing, the Corporation shall have the right to increase its capital stock either with or without par value and to provide in the event of such increase the designation, preferences, voting powers or restrictions qualifications of voting such powers, or additional stock in amendment an to its Certificate of Incorporation.
- D. There shall be no preemptive rights.

ARTICLE IV

INITIAL CAPITAL

The amount of capital with which this Corporation shall begin business is not less than one thousand dollars (\$1,000.00).

ARTICLE V

TERM OF EXISTENCE

This Corporation shall exist perpetually unless dissolved according to law.

ARTICLE VI

CORPORATE OFFICE

The street address of the office of the Corporation will be 4788 Oakley Rd., North Port, FL 34288. The Board of Directors shall have the power to establish branch offices and to move the principal office to any other address in Florida.

ARTICLE VII

BOARD OF DIRECTORS

- A. The Board of Directors of this Corporation shall consist of at least one (1) Director, but not more than five (5) Directors.
- B. The number of Directors may be increased or diminished from time to time by Bylaws adopted by the Stockholders.

C. The names and street addresses of the initial members of the Board of Directors, to hold office for the first year of existence of this Corporation or until their successors are elected or appointed and have qualified are:

BYLAWS


