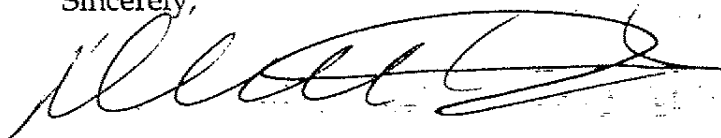

*Name of Corporation*

The name of this corporation shall be:

**ARTICLE II**

*Purposes*

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law either now existing or hereafter enacted.

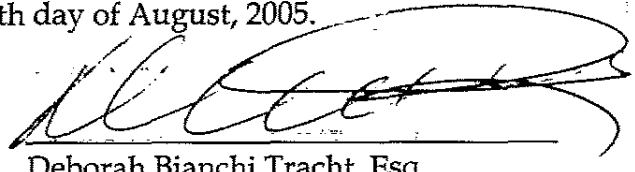
## **ARTICLE XIII**
