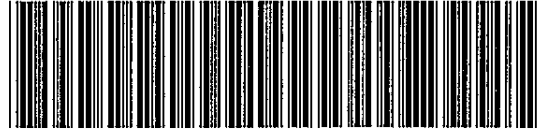




ARTICLE X. AMENDMENT

ARTICLE XI. EFFECTIVE DATE

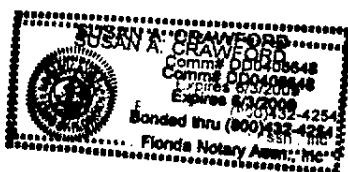


