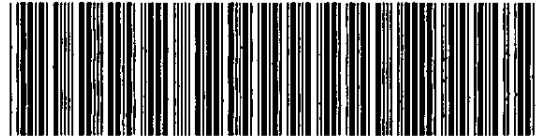



FIRST: The new name of the corporation is: GOLF IN PARADISE REALTY, INC.


SECOND: The following amendment to the Articles of Incorporation was adopted by the corporation:
