**ARTICLES OF INCORPORATION
OF**

DECK PRO TECH, CORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Deck Pro Tech, Corporation.

ARTICLE II

The street address of the principal office of the Corporation is 4648 Brook Drive, West Palm Beach, Florida 33417. This is also the mailing address.

ARTICLE III

The general purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, par value \$.01 per share, all of which shall be Common Shares. The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.


