### **ARTICLE I**

#### **Name of the Corporation**

### **ARTICLE II**

#### **Nature of Business**

The general nature of the business to be transacted by this Corporation is: Any activity or business permitted under the laws of the United States and the State of Florida.

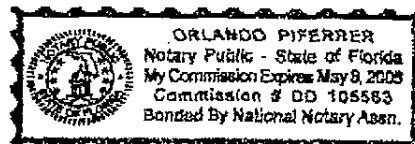
