



ARTICLES OF INCORPORATION

OF

BAL HARBOR DEVELOPMENT III, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the law of the State of Florida.

ARTICLE 1. - NAME AND ADDRESS

The name of this corporation is BAL HARBOR DEVELOPMENT III, INC., a Florida corporation, and the principal office is located at 18501 Murdock Circle, Suite 101 Port Charlotte, Florida 33948.

ARTICLE 2. - DURATION OF CORPORATION EXISTENCE

The corporation shall exist perpetually.

ARTICLE 3. - PURPOSES

The general purposes for which this corporation is organized include the transaction of any or all lawful business for which corporations may be incorporated under the provisions of Chapter 607, Florida Statutes, as the same now exists or as it may hereafter be changed.
