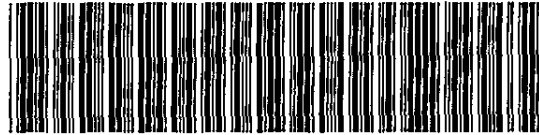

ARTICLE I - NAME

The name of this corporation is JM Recapture, Inc.

ARTICLE II - PRINCIPAL OFFICE

This corporation is organized for the purpose of transacting any or all lawful business.
