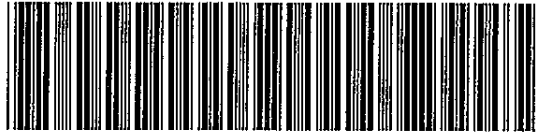

ARTICLES OF INCORPORATION

OF

In Compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") shall be L. G. AVILES TRUCKING Company, Inc.

ARTICLE II

The street address of the principal office of the Corporation is 4105 Leonard Street, Valrico, FL 33594 and its mailing address is 4105 Leonard Street, Valrico, Florida 33594.

The maximum number of shares this Corporation is authorized to issue is 100, par value \$.01 per share, all of which shall be Common Shares. 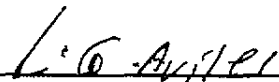

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

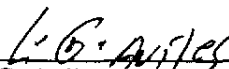
