# ARTICLES OF INCORPORATION

OF

### FLATHEAD INVESTORS, INC.

The undersigned, acting as incorporator of FLATHEAD INVESTORS, INC. (the "Company") under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I. NAME AND ADDRESS
