ARTICLES OF INCORPORATION
OF
ALL-IN-ONE HOME SERVICES, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I - NAME

The name of this corporation is All-In-One Home Services, Inc.
