The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article 1 - Name and Address

Article 5 - Initial Directors & Officers

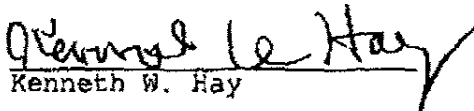
The Corporation shall initially have one (1) Director, Kenneth Hay, and Kenneth Hay shall initially serve as the President, Secretary, and Treasurer.

Article 6 - Incorporator

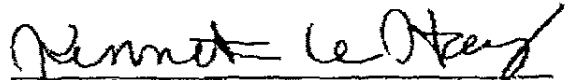
