## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ROTEK, INC.

Pursuant to the provisions of section 607.1006 of the Florida Statutes, ROTEK, Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation which were filed with the Florida Department of State on August 29, 2005, as document number P05000119982.

FIRST: Article  $\Pi$  is changed as follows:
