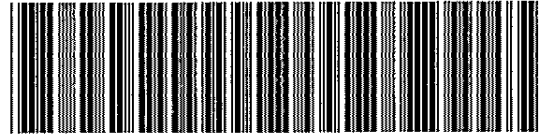

ARTICLE I - NAME

The name of this corporation shall be:

The general nature of the business to be transacted by this corporation is:

ARTICLE XIII - EFFECTIVE DATE

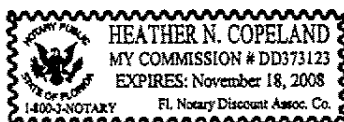
