# ARTICLE I Name and Duration

The name of the Corporation is Ron Adams Services, Inc. The duration of the Corporation is perpetual. The Corporation shall begin its corporate existence as of the date that these Articles are filed by the Secretary of State.

# ARTICLE II Principal Office

The address of the principal office and mailing address of the Corporation in the State of Florida is 1423 Wolf Trail, Middleburg, Florida 32068.

# ARTICLE III Registered Office and Agent
