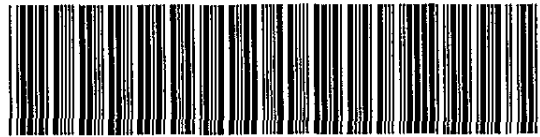

NAME

The name of this corporation is Cut Throat Entertainment, Inc.

ARTICLE II.
PRINCIPAL OFFICE

DURATION; EFFECTIVE DATE
