Name. The name of this corporation is The Speed Doctor, Inc.

ARTICLE II

Duration. The corporation shall be perpetual.

ARTICLE III

Capital Stock. This corporation is authorized to issue 1,000 shares of common stock at \$1.00 par value, which shall be designated "Common Shares".
