ARTICLE I. - NAME

The name of this corporation is OCALA FONDUE, INC.

ARTICLE IL - DURATION

This corporation shall have perpetual existence, commencing on August <u>30</u>, 2005.

ARTICLE III. - PURPOSE

This corporation is organized to transact any and all lawful business.

ARTICLE IV. - POWERS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.


