Articles of Incorporation of MGT Premier Airport Resources, Inc.

THE UNDERSIGNED, being of legal age and a natural person, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

FIRST: The name of this corporation shall be:

MGT Premier Airport Resources, Inc.

SECOND: This corporation shall commence its existence on the date of the filing of these Articles of Incorporation with the Florida Department of State and this corporation shall exist perpetually thereafter unless sooner dissolved according to law.

TRIED: This corporation may engage in any activity or business permitted under the laws of the State of Florida.

FOURTH: This corporation is authorized to issue One Thousand (1,000) shares of common stock which shall be designated as "common shares".
