**ARTICLE 5 - CAPITAL STOCK**

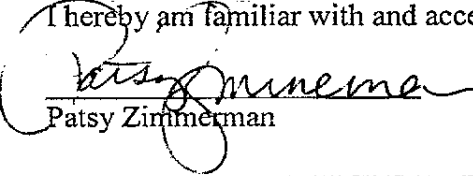

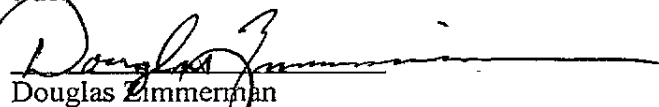
