The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation in compliance with Chapter 607 and/or Chapter 621, Florida Statutes, (Profit):

ARTICLE I - NAME

The name of the corporation is T-N-T MEDICAL SERVICES, INC.

ARTICLE II - DURATION

The duration of the corporation is perpetual.

ARTICLE III - PURPOSE

The general purposes for which the corporation is organized are:
