**ARTICLES OF INCORPORATION
OF

The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: **Stephen Carlson Roofing, Inc**

ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE


