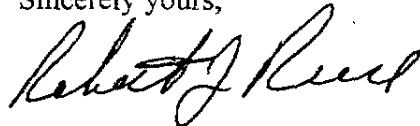

ARTICLES OF INCORPORATION

OF

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby associates himself to form a Corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this Corporation is:

RJR MANAGEMENT, INC.

ARTICLE II. ADDRESS

The initial post office address of the principal office of this Corporation in the State of Florida is 802 Ocean Marina Drive, Flagler Beach, Florida 32136. The Board of Directors may, from time to time, move the principal office to any other address in Florida.

ARTICLE III. PURPOSE

The purposes for which this Corporation is formed is to engage in every phase and aspect of the general business of management for consumers, for real property, and any other types of management ventures.

ARTICLE IV. CAPITAL STOCK

The effective date of incorporation shall be **August 30, 2005**.

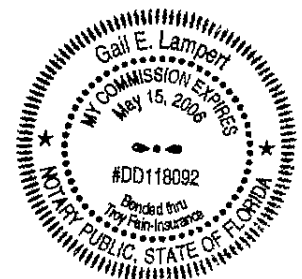

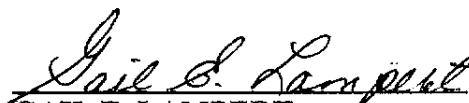
