ARTICLE I



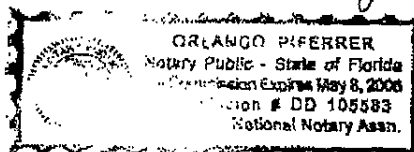


