**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION OF
FIRST COAST COMMUNITY ASSOCIATION MANAGEMENT, INC.**


1. The name of this Corporation is First Coast Community Association Management, Inc. (the "Corporation").
2. These Articles of Amendment were duly recommended by the Board of Directors and duly adopted by a unanimous vote of the Corporation's Shareholders on March 2, 2006, which vote was sufficient for approval.
3. Pursuant to the provisions of Section 607.1006, Florida Statutes, this Amendment amends the Articles of Incorporation of First Coast Community Association Management, Inc. filed September 1, 2005, effective August 31, 2005, to change the name of the Corporation to "BAH Investments, Inc." Accordingly, Article I of the Articles of Incorporation is hereby amended and restated as follows:

**ARTICLE I.
NAME AND ADDRESS**
