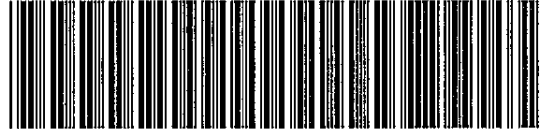

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is JIM LANKFORD, INC., and the principal address and principal place of business is 4199 RIDGEMOOR DRIVE NORTH, PALM HARBOR, FLORIDA 34685.

ARTICLE II - REGISTERED OFFICE AND AGENT

ARTICLE VI - AMENDMENTS


