This letter is on behalf of West Gulf Real Estate and Development, Inc. On 10/10/06 we received a Notice of Dissolution. According to our files, we received a notice of intent to dissolve back in May, 2006 after receiving a letter (letter number 306A00035818) which stated that the documents for our filing in 2006 were received, but no check was enclosed. Our office manager contacted one of your examiners. We came to the conclusion that when we filed this year, the check that was enclosed was for a total of \$325.00. This amount was meant to be applied to our corporation's fees as well as a few other LLCs. This check was cashed and since it was sent with the form belonging to the name of our corporation, (West Gulf Real Estate and Development, Inc.) it was meant to be applied to the corporation's fees first. The examiner we spoke with said that in order to fix the error, we would have to fax over a copy of the check, a letter of explanation, and a copy of our annual report. We faxed over all of the requested documents to Gary (the examiner we spoke with).

After receiving the notice of dissolution, we spoke with yet another examiner who suggested we resent the documents since it seems there are no records of anything being filed for us this year.
