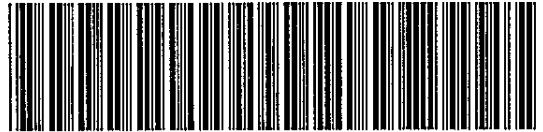

ARTICLE I - NAME

The name of the corporation is **PACE GUTTERS, INC.**

ARTICLE II - DURATION

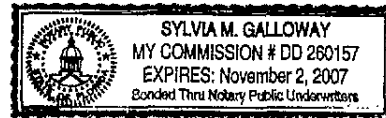
