ARTICALS OF INCORPORATION OF

The undersigned subscriber to these Articles of Incorporation, a natural person competenting to contract, hereby forms a Corporation under the Laws of the State of Florida.

Article 1 Name

The name of the Corporation shall be Appraisers Plus Corporation.

Article II Nature of Business

This Corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.

Article III Term of Existence

The period of this Corporation shall be perpetual commencing on the date of execution. The existence of the corporation shall begin as of the filing date with the Department of State.
