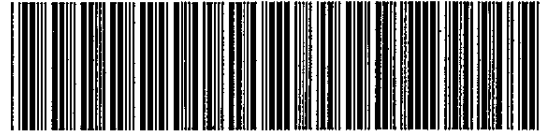

# ARTICLES OF INCORPORATION

OF

## APPRAISERS PLUS CORPORATION

In compliance with Chapter 607 and/or Chapter 621, F.S. (PROF) SEP -2 PM 2: 25

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation under the Laws of the State of Florida.

### Article I Name

The name of the Corporation shall be Appraisers Plus Corporation.

### Article II Nature of Business

This Corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.

### Article III Term of Existence

The period of this Corporation shall be perpetual commencing on the date of execution. The existence of the corporation shall begin as of the filing date with the Department of State.

### Article IV Principal Office and Registered Agent

The street address of the initial registered and Principal Office of the Corporation shall be 2222 Walkers Glen Lane, Jacksonville, Florida 32246. The name of the initial registered agent of this Corporation is Paul Jarnutowski and I hereby am familiar with and accept the duties and responsibilities as Registered Agent.

### Article V Capital Stock

This Corporation is authorized to issue 1,000 shares of common stock having a par value of One Dollar (\$1.00) per share and will be divided as follows:

- a. 500 shares of voting common stock designated as Class A.
- b. 500 shares of nonvoting common stock designated as Class B.

### Article VI Limitation of Liability

Each director, stockholder and officer, in consideration for his services, shall, in the absence of fraud, be indemnified, whether then in office or not, for the reasonable cost and expenses incurred by him in connection with the defense of, or for advice concerning any claim asserted or proceeding brought against him by reason of his being or having been a director, stockholder or officer of the Corporation or of any subsidiary of the Corporation, whether or not wholly owned, to the maximum extent permitted by law. The foregoing right of indemnification shall be inclusive of any other rights to which any director, stockholder or officer may be entitled as a matter of law.

**Article VII            By – Laws**

The powers to adopt, alter, amend or repeal By – Laws shall be vested in the Board of Directors and Shareholders.

**Article VIII           Initial Board of Directors**

The Corporation shall have two (2) Directors initially. The number of Directors may either be increased or diminished from time to time by the By – Laws, but it shall never be less than one. The name and address of the initial Directors of this Corporation is

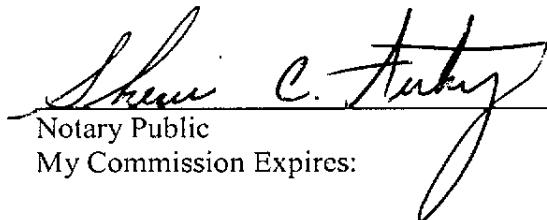
