

**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is First Step Foliage-Brokerage Inc. principal place of business shall be located at P.O. BOX 901860 Homestead, Florida 33030.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.
