ARTICLES OF INCORPORATION OF LEEWAY HOME MAINTENANCE, INC.

ARTICLE I - NAME

The name of this corporation is **LeeWay Home Maintenance**, Inc. located at 914 St. Clair, Suite M58, Melbourne, Florida 32935.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE
