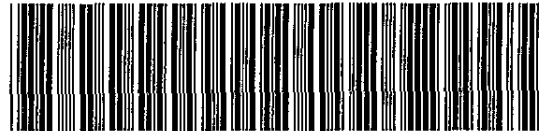

**ARTICLE I - NAME**
