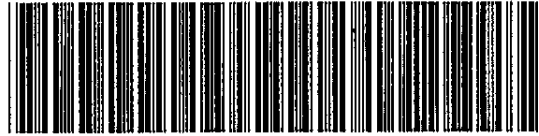

ARTICLES OF INCORPORATION

ARTICLE I
(Name)

The name of the corporation shall be TROPICALIS CORPORATION.

ARTICLE II
(Principal Office)

(Purpose)

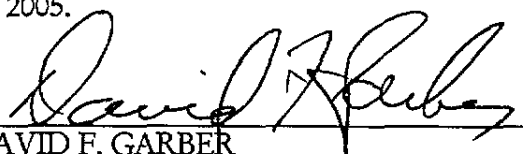
ARTICLE X
