#### ARTICLES OF INCORPORATION

#### **OF**

#### EASY TRADE OF SOUTHWEST FLORIDA, INC.

The undersigned does hereby execute these Articles of Incorporation for the purpose of becoming a corporation organized under the laws of the State of Florida, by and under the provisions of the Statutes of said State providing for the formation, liability, rights, privileges and immunities of a corporation.

# ARTICLE I

(Name)

The name of this corporation shall be: Easy Trade of Southwest Florida, Inc.

(Duration)

The corporation is to commence its corporate existence on the date of filing these Articles of Incorporation with the Florida Department of State and shall exist perpetually thereafter until dissolved according to law.

### ARTICLE III

(Purpose)

The general nature of the business to be transacted by this corporation is as follows: To own, operate, manage and run a website or websites or other media, and to use said media to report on corporate stock information/data and/or other financial opportunities or investments to consumers and website members; and to engage in any other lawful activity of business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

Shares may not be issued until the full amount of the consideration therefor has been paid. Thereafter, such shares shall be deemed to be fully paid and nonassessable.

# ARTICLE Y

(Preemptive Rights)

Every Shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his or her prorata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE VI

(Board of Directors)

All corporate powers and business affairs of the corporation shall be exercised by and managed under the direction of a Board of Directors.

The corporation shall have one director initially. The number of directors may thereafter by increased or decreased from time to time in accordance with the Bylaws of the corporation.
