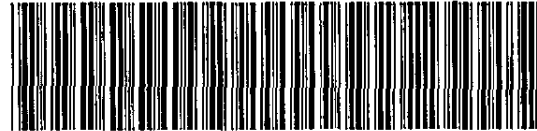

AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF

THE DATING SPACE, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following amendment and restatement of its Articles of Incorporation, said Articles of Incorporation being filed with the Secretary of State, Tallahassee, Florida on September 9, 2005:

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

THE DATING SPACE, INC.

The address of the principal office of this corporation shall be 4109 Central, Tampa, Florida 33603, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having \$1.00 par value per share.
