## ARTICLES OF INCORPORATION OF SUE TYE, INC.

#### ARTICLE I

#### **NAME**

The name of the corporation is SUE TYE, INC. and its mailing address is 4961 Ridgemoor Blvd., Palm Harbor, FL 34684.

#### **ARTICLE II**

#### **DURATION**

This corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of Florida.

#### **ARTICLE III**

#### **PURPOSE**

This corporation is organized for the purpose of providing real estate and brokerage services and for such other services as it may be registered and licensed to provide.

#### **CUMULATIVE VOTING**

At each election for directors every shareholder entitled to vote at such election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principle among any number of such candidates.

#### ARTICLE IX

#### PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE XI

#### **BYLAWS**

The initial Bylaws shall be adopted by the Board of Directors. The power to alter, amend or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the shareholders.
