## ARTICLE OF INCORPORATION OF AMERICAN HOME & BUILDING INSPECTORS, INC.

The undersigned subscribers to these Articles of Incorporation are a natural person competent to contract and hereby form for profit Corporation under Section 607 of the Florida Statutes.

#### **ARTICLE 1- NAME**

The Name of the Corporation is AMERICAN HOME & BUILDING INSPECTORS, INC. (hereinafter, ("Corporation").

#### **ARTICLE 2- PURPOSE OF CORPORATION**

- 7.4 The Board of Director(s) of the Corporation may, by Restated Articles of Incorporation, classify or reclassify any unissued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.

#### **ARTICLE 8- POWERS OF CORPORATION**

The Corporation shall have the same powers as an individual to do all things necessary or convenient to carry out its business and affairs, subject to any limitations or restrictions imposed by applicable law or these Articles of Incorporation.
