of

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation is: Native Strategies, Inc.

ARTICLE II
DURATION

The term of the existence of the corporation is perpetual and shall commence on the date of filing of these Articles.

ARTICLE III
PURPOSE

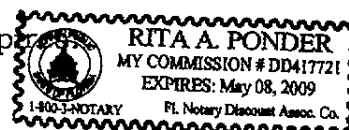
