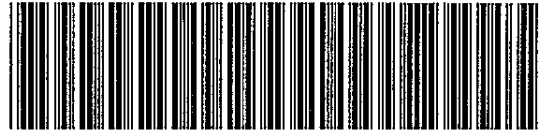





OTHER PROVISIONS:




