ARTICLES OF INCORPORATION
OF

ARTICLE I—NAME

The name of this corporation is JERRY PRATT STUCCO, INC.
The address of this corporation is 485 CANAVERAL GROVES BLVD., COCOA BEACH, FL 32926 and its mailing address is 485 CANAVERAL GROVES BLVD., COCOA BEACH, FL 32926.

ARTICLE II—DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III—PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business under the laws of the State of Florida and the United States of America.

ARTICLE IV—CAPITAL STOCK

This corporation is authorized to issue 750 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

ARTICLE V—PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

This election has the legal effect of granting the shareholders a preemptive right on uniform terms and conditions prescribed by the Board, to acquire proportional amounts of JERRY PRATT STUCCO, INC. unissued shares after the Board decides to issue new shares. This provision is to protect shareholders from dilution of their proportionate interest, control and value of JERRY PRATT STUCCO, INC. stock.

A shareholder may waive his preemptive right upon written notice to the Board and such waiver is irrevocable.

ARTICLE VI—INITIAL REGISTERED OFFICE AND AGENT
