

#### ARTICLES OF INCORPORATION

OF

ANCHOR REALTY TREASURE, INC.

The undersigned incorporators hereby form a corporation under Chapter 607 of the laws of the State of Florida.

#### ARTICLE I. NAME

The name of the corporation shall be: ANCHOR REALTY TREASURE, INC. The address of the principal office of this corporation shall be: 3200 N.E. 14<sup>th</sup> Street, Suite 222, Pompano Beach, Florida 33062, and the mailing address of the corporation shall be the same.
