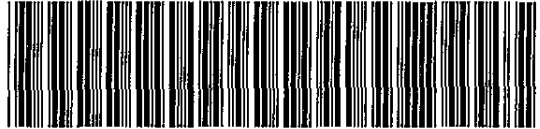

The number and type of officers may change from time to time by the bylaws, but shall never be less than one officer consisting of a President/Secretary.

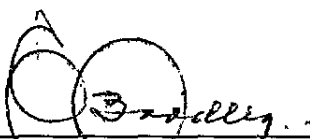

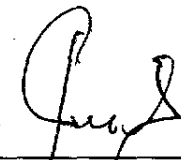

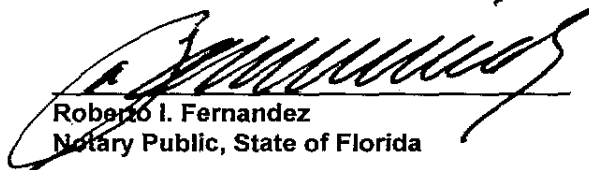
