The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I  
NAME AND PRINCIPAL OFFICE**

The name of this corporation is Jumpers.Kids, Inc., and its principal office is located at 8522 Kingfisher Way, Pensacola, Florida 32534 and its mailing address is 8522 Kingfisher Way Pensacola, Florida 32534

**ARTICLE II  
DURATION**

This corporation shall exist perpetually.

**ARTICLE III  
PURPOSE**

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV  
CAPITAL STOCK**
