

ARTICLE I

NAME: The name of this Corporation is SUNSHINE COTTAGES, INC., and its address is 5503 Sir Churchill Dr., Leesburg, FL 34748.

ARTICLE II

DURATION: This Corporation shall exist perpetually.

ARTICLE III


