ARTICLES OF INCORPORATION

PEACHTREE COMMERCIAL REALTY, INC.

The undersigned, for the purpose of forming a corporation under the provisions of the FLORIDA GENERAL CORPORATION ACT, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is PEACHTREE COMMERCIAL REALTY, INC.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The corporation may engage in the operation of a real estate agency or to enter into any other business activity authorized under the laws of the State of FLORIDA or of the laws of the United States.

ARTICLE IV

The Corporation shall have authority to issue one (1) class of Capital Stock which shall consist of five thousand (5,000) shares of one dollar (\$1.00) PAR value Common Stock.

ARTICLE V

The corporation shall commence business upon the approval of these Articles of Incorporation.

ARTICLE VI

The principal place of business shall be located in LEE County, Florida. The address of the principal place of business shall be 2323 DEL PRADO BLVD #1B, CAPE CORAL, FLORIDA.
